1. Hours: 7:00 a.m. to 7:45 a.m. and 2:45 to 6:00 p.m.
NO CHARGE 7:30 – 7:45 a.m. and 2:45 to 3:00 p.m.
2. Charge: See Rate Schedule
3. Late Fee: For Children not picked up by 6:00 p.m. parent/guardian will be charged \$5.00 for the first five minutes and \$5.00 per minute thereafter.
4. There is annual material and service fee per student \$30.00 for grades K-8 and \$75.00 for a family of three or more.
5. Snacks will be provided. Donations are appreciated and count towards Parents' Club general hours.
6. Students may NOT change into play clothes.
7. There will be one hour of homework time Mon. – Thurs. All students are expected to participate. Please enter classroom quietly when picking up your child during homework time.
8. Students on campus before 7:45 are to go to the Extension Program. This is for the protection and safety of the students.
9. Students on campus after 3:00 are to go to the Extension Program Room.
10. A parent/guardian must come to the Extension Program Room and sign out the child/ren.
11. If someone whose name is not on our Extension Release Form comes to pick-up a student, they will be not allowed to do so unless a parent or guardian has notified us beforehand. Written notification is preferred. If we have not been notified the student will not be released.
12. If a bill is not paid within four weeks of the due date, the student may no longer participate in the Extension Program. Late payment fee is \$25.00 per month until payment is made.
13. If a student's behavior is consistently disruptive the student may be excluded from the Extension Program.
